Rate Agreement and Contract

Hours of Operation

After-School regular operating hours are **Monday through Friday from 2:30 PM to 5:30 PM** except closings for various holidays, as described in the Family Handbook. Please consult the current school calendar for holidays and after-school closings. There is no reduction in tuition as a result of center closures.

Day Camp will operate **Monday through Friday from 7:30 AM to 5:30 PM on days intended for inclement weather, school closings, some holidays, and summer break.** This will not include major holiday breaks, as described in the Family Handbook.

The procedure to notify families should severe weather or other conditions prevent the program from opening on time or at all will be announced via phone call or text message. If it becomes necessary to close early, we will contact you or someone listed in the *Emergency Contact and Release*, and it will be your responsibility to arrange for your child's early pick up.

- For the first month of attendance , tuition will be pro-rated.	
- Tuition is due and payable on the first business day of each month, following the initial payment.	
- Tuition is \$220/month and is not subject to discounts for holidays, emergency closures (i.e., weather), or absence.	
- I agree to pay the full tuition in advance of services rendered.	
- I agree to pay the full tuition fee even if my child is absent for one or more days.	
- An additional fee of \$20 is due if tuition is not received on time.	
- A non-refundable registration fee of \$20 is due for first-time registrants.	
- Every child must be picked up no later than 5:30 PM. Failure to do so will result in a \$15 fee per child per every 15 minutes past closing time.	
- Accounts two weeks in arrears may result in immediate termination of service.	
- My child may have the opportunity to participate in a special program or field trip that may have an additional fee due before the day of the event. A specific permission slip may be required.	
- All returned checks will carry a fee of \$25. Two or more returned checks will result in my account being placed on "cash only" status.
